FEES AND CHARGES REGULATION

Part 1 – Preliminary

1. Short Title

This regulation may be cited as the Fees and Charges Regulation.

2. Commencement

This regulation commences on 1 August 2012.

3. Purpose of Regulation

The purpose of this regulation is to:

- (a) establish the prescribed fees and charges for the operation of the association, including but not limited to membership fees and alpaca registration fees, and
- (b) establish all other matters incidental and relevant to regulation 3 (a).

4. Definitions

In this regulation:

"**Director-General**" means the Director-General of the Department of Fair Trading.

"**the Act**" means the *Associations Incorporation Act 1984*.

"**association**" means AABA.

"**AABA**" means the Australasian Alpaca Breeders Association, Inc.

"**GST**" means Goods and Services Tax.

"**AAR**" means Australasian Alpaca Register.

5. Notes

Any explanatory notes and tables of contents do not form part of this Regulation.

Part 2 – Fees

6. Annual Membership Subscription

- (1) The annual membership subscription is payable for the year ending 30 June.
- (2) The amount payable is detailed in Schedule 1.
- (3) Memberships lapse at midnight, 31 July.

7. Other Fees and Charges

Other fees and charges payable from time to time are detailed in Schedule 1.

8. Goods and Services Tax

- (1) AABA is deregistered for GST.
- (2) Fees quoted in Schedule 1 do not include GST.
